

# FLP Safety Protocols Things FLP Parents Should Know

- 1. Safety is our top priority when FLP beings on September 11.
- 2. FLP will follow Dallas ISD's COVID safety protocols.
- 3. FLP students, faculty and visitors will be required to wear masks indoors during FLP program hours and on FLP-sponsored buses.
- 4. Face masks and hand sanitizer will be available on-site.
- 5. We will maintain three feet of distance (six feet when appropriate).
- 6. Handwashing is an important and recommended preventative strategy.
- 7. FLP students, faculty, and staff should self-check temperature each day and stay home when ill; no on-site temperature checks will be done.
- 8. Contact tracing for positive cases will be conducted, in collaboration with Dallas ISD and the Dallas County Health Department\*.

<sup>\*</sup>We will continue to follow updated safety guidelines based on the direction of the CDC and Dallas County Health Department.

### **Self-Screening**

FLP students and faculty should self-screen before going to an FLP bus location by checking their own temperature, and determining if they have any of the following new or worsening signs or symptoms of possible COVID-19:

- Cough, shortness of breath/difficulty breathing
- Chills/repeated shaking with chills
- Muscle aches/body aches/fatigue
- Headache
- Sore throat
- Congestion or runny nose
- Loss of taste or smell
- Nausea/vomiting/diarrhea
- Fever of 100.4 or greater
- Known close contact with a person who has COVID

Students running a fever of 100.4 or higher, or feeling ill, should stay home and not report to FLP. Contact the FLP office at <a href="mailto:flp@brewerfoundation.com">flp@brewerfoundation.com</a> to notify them of your child's absence.

Staff running a fever of 100.4 or higher, or feeling ill, should stay home and not report to FLP. Contact the FLP office immediately to notify them of your absence.

### **Contact Tracing**

FLP will conduct contact tracing in the 2021-2022 academic year. If there is a positive case identified, the FLP office will identify and notify close contacts. FLP will also collaborate with Dallas ISD and county health officials as needed.

#### **Quarantine Protocols**

Students who had close contact with a person known to have COVID-19 should not report to FLP for 14 days after their last exposure to that person, or the following FLP session. However, anyone who has had close contact with someone with COVID-19 and who meet the following criteria **can** report to FLP:

Someone who has been <u>fully</u> vaccinated and shows no symptoms of COVID-19.
However, fully vaccinated people should get tested 3-5 days after exposure, even if they don't have symptoms and wear a mask indoors in public for 14 days following exposure or until their test result is negative.

OR

- Tested positive for COVID-19 within the past three months, <u>AND</u>
- Has recovered, AND
- Remains free of any COVID-19 symptoms (e.g., cough, shortness of breath)

## NOTE: FLP requires vaccinated/unvaccinated students, faculty and visitors to wear masks indoors during FLP program hours and on FLP-sponsored buses.

Unvaccinated students/staff who have had close contact with a person known to have COVID-19:

- Quarantine at home and be tested 5 to 7 calendar days after exposure. If negative and symptom free return to FLP on day 8, or the following FLP session.
- Without a test, quarantine for 10 calendar days and return to FLP on day 11, or the following FLP session.

Students/staff who test positive for COVID-19 may not return to FLP until:

- At least 24 hours without a fever and
- Symptoms have improved (cough, headache, sore throat, etc.) and
- At least 10 days have passed since symptoms first appeared, or
- Note from a medical professional to return to FLP.
